**Sub: Closure of Trading Window for Board Members and Designated Persons along with their immediate relatives.**

The demat accounts shall be identified by the depositories (NSDL/CDSL) based on the PAN of the DP of Sole / Joint holder. Depositories and Stock Exchanges will freeze the PAN of Designated Persons w.e.f. 01.10.2025 till the end of trading window closure period.
