I, Vandana Nahata, Practising Chartered Accountant (ACA—302614) and proprietor of M/s. Vandana Nahata & Co, Chartered Accountants (FRN-328546E), was appointed as the scrutinizer by the Board of Directors of Shelter Infra Projects Limited (**"the Company"**) in connection with the 51<sup>st</sup> Annual General Meeting of the Members of **"Shelter Infra Projects Limited"** (**"The Company"**) held on Friday, 08<sup>th</sup> September, 2023 in accordance with the applicable provisions of the Companies Act 2013 read with MCA General Circular No. 02/2021, 20/2020, 14/2020, 17/2020, 02/2022 and 10/2022 dated 13<sup>th</sup> January 2021, 5<sup>th</sup> May 2020, 8<sup>th</sup> April 2020, 13<sup>th</sup> April 2020, 5<sup>th</sup> May 2022 and 28<sup>th</sup> December 2022 respectively at 12.30 pm IST through VC/OAVM for the purpose of scrutinizing the process of voting through electronic means (e-voting) in a fair and transparent manner and ascertaining the requisite majority for the said voting as per the provisions of the Companies Act, 2013 and Rule 20 of the Companies (Management and Administration) Rules, 2014, as amended, on the resolutions referred to in this report.

The Management of the Company is responsible to ensure the compliance with the requirements of the Companies Act, 2013 and Rules relating to remote e-voting and voting process on the resolutions contained in the Notice of the Annual General Meeting dated 18<sup>th</sup> July, 2023. My responsibility as a scrutinizer for remote e-voting and voting process is restricted to make a Scrutinizer's Report of the votes cast "in favour" or "against" the resolutions, based on the reports generated from the e-voting system of National Securities Depository Limited (NSDL), the agencies engaged by the Company to provide remote e- voting facility.

I submit my report as under:

1. The remote e-voting period remained open from 9.00 A.M. IST on Tuesday, the 5<sup>th</sup> September, 2023 up to 5.00 P.M. IST on Thursday, the 7<sup>th</sup> September, 2023.
2. The Shareholders holding shares as on the "cut off" date, i.e. Friday 1<sup>st</sup> September, 2023 were entitled to vote on the proposed 4 (Four) resolutions as mentioned in the Notice dated 18<sup>th</sup> July, 2023 of the Annual General Meeting of the Company.
3. In view of the recent ongoing pandemic and in accordance with the applicable provisions of the Companies Act 2013 read with MCA General Circular No. 02/2021, 20/2020, 14/2020 and 17/2020 dated 13<sup>th</sup> January 2021, 5<sup>th</sup> May 2020, 8<sup>th</sup> April 2020, 13<sup>th</sup> April 2020, 5<sup>th</sup> May 2022, 02/2022 and 10/2022 dated 13<sup>th</sup> January 2021, 5<sup>th</sup> May 2020, 8<sup>th</sup> April 2020, 13<sup>th</sup> April 2020, 5<sup>th</sup> May 2022 and 28<sup>th</sup> December 2022 respectively, the Annual General meeting was held through VC/OAVM mode only to enable the shareholders to cast the votes through remote e-voting only.




